Santa Monica's Future

Friends talked to the Santa Monica Planning Dept. and found out some interesting statistics. Did you know that Santa Monica is the second most dense city in all of Los Angeles County, second only to West Hollywood? ("Density" is number of residents per square mile.) The statistics are: West Hollywood-19,653 residents per square mile; Santa Monica-12,751; and Redondo Beach-10,668. Los Angeles is way down on the list at 8,155 and Culver City is only 8,607. (Source: City of Santa Monica Housing Element, Table C-5)

Santa Monica is considered an already "built-out" city—since we have no further room to grow. The question is how many more residents/commercial development do we add to our acreage? No wonder traffic and over-development have become such major issues in our City! Also, we are apparently being penalized for having done a good job of residential unit production in the past. To deal with the large increase in population in Southern California, the State Housing and Finance Depts. decide how much housing each city must add. Santa Monica was given a big increase because we already had produced a good share of housing in the past. Cities that had done less, such as Culver City, are being given a smaller amount. In fact, according to Jay Trevino of the Santa Monica Planning & Zoning Dept., of the four westside cities in our planning region (Culver City, Beverly Hills, West Hollywood, and Santa Monica) Santa Monica is being given almost half the total housing requirement! The City fought to lower our limit, but we still must produce 2200 units this year.

This information is important because continued growth citywide impacts all of us. Do we really want to overtake West Hollywood and become "Number One" in density? What impact would that have on our quality of life? What do we want our "built-out" City to look like in the future?

These are important questions, and they are good reasons to keep informed on City-wide issues and to keep in touch with your City Council members.

Santa Monica College Update

The Friends of Sunset Park College Committee met with SMC Executive VP Tom Donner to get an update on projects. Following are some of the things that could impact the neighborhood in various ways.

Replacement Parking Structure

SMC hopes to begin construction by the end of June on the replacement for the structure that was torn down after the Northridge Earthquake. A dispute between the Pico Neighborhood and the city over traffic patterns at 17th and Pico could impact the project but, as of mid-May, the judge had not issued an injunction to block construction. FEMA is providing \$1.5 million and SMC is requesting \$5.5 million of Earthquake Recovery funds from the city.

New Liberal Arts Building

SMC plans to build a new Liberal Arts building to replace the existing earthquake damaged building, which would be demolished. The new complex would be located just east of the new parking structure, and be 50,000 square feet vs. 36,000 square feet for the existing building. SMC will receive \$3 million (the approximate cost to fix the old building) from FEMA, and will seek \$4 million from the state and \$6 million of earthquake funds from the city (\$10 million from Santa Monica if there are no funds from the state).

Fourteenth and Pico Property

SMC will seek a permit from the city to use this site at the southeast corner of Pico and 14th as an offsite construction storage yard in connection with the library expansion on the main campus. Eventually, SMC plans to build a Literacy Center on the site.

Library Expansion

SMC hopes to begin construction on the library expansion in July.

Swimming Pool

The timing of completion of the swimming pool on campus, which is a Santa Monica City project, is uncertain because of construction delays.

Offsite Plans

SMC is looking to satellite locations to expand, including its Madison site, where it hopes to demolish the auditorium and build a new 500-seat theater which would become part of a performing arts complex. Also, SMC will hold some classes this summer at the University of West Los Angeles near LAX.

Friends Position

Friends of Sunset Park does not believe the city should provide any funding that would allow SMC to grow on its main campus. We support higher education, but there has to be a balance when unlimited college growth negatively impacts the surrounding community.

Noise Ordinance Revision Update

The Santa Monica Airport Commission meeting for May 2001 is scheduled on Thursday, May 31st, 7:00 pm at the Ken Edwards Center on 4th Street between Broadway and Colorado. Parking is in the rear of the building. PLEASE NOTE THE CHANGE IN DAY, TIME, AND LOCATION OF THIS MEETING due to the Memorial Day Holiday.

Noise Ordinance Revision "concepts" will be discussed by the Commission and Staff. A recommendation will then be forwarded to the City Attorney's Office. Drafting of the Noise Ordinance Revision will be done by the City Attorney's Office and presented to the City Council for consideration.

Hopefully, this will be the last Airport Commission Meeting that this item will be discussed. We are looking forward to its FINAL presentation to the City Council. LAX Master Plan Expansion

On January 18, 2001, Los Angeles World Airports (LAWA) issued their Draft Environmental Impact Report for their latest options for the proposed LAX Master Plan. Santa Monica City Councilmember Kevin McKeown requested an extended 180-day public and agency comment period. To view this Environmental Impact Report and other information on the LAX Master Plan, see the LAWA web site at "http://www.laxmasterplan.org."

The Santa Monica Airport Staff report in January 2000 states that previous LAX releases have indicated the desire to shift more regional operations to feeder airports. Read: send corporate jets to other local airports, i.e. Santa Monica Airport (SMO). SMO was never intended to accommodate the jet traffic currently utilizing its facilities, let alone absorb more. For LAWA to offer this "solution" to one of their "problems" is really only shoving the problem on to someone else's doorstep. The City of Santa Monica is working in conjunction with other communities surrounding LAX to create a united front and prepare a submission to the LAWA. This submission will express the opinions and concerns of these communities and the impact the proposed expansion options will have on all of us.

Public comment will be received until July 25, 2001. Please submit your comments to LAWA at: LAX Master Plan, P.O. Box 92216, Los Angeles, CA 90009-2216. There are simultaneous Public Hearings scheduled for Saturday, June 9th, 2001 from 12:00–7:00 pm. You can express your opinions in person at any of the following three locations: The Furama Hotel at Lincoln and Manchester, the Pavilion at Hollywood Park, and the Manhattan Beach Marriot.
