"My History in Santa Monica"

he earliest I can recall is when I lived on Raymond Avenue. Raymond currently stops at 4th Street, but in 1933 it went all the way to the beach.

One evening, we heard on the radio that there was a large earthquake off the coast of Long Beach. They also said it was possible that a tidal wave would cover all

coast of Long Beach. They also said it was possible that a tidal wave would cover all the low areas and that we should go to higher ground. We walked up the street and caught a streetcar to Santa Monica Blvd. The streetcar used to run where Neilson Way is today. When we arrived in Santa Monica, the Palisades was crowded with people. There were very few cars then, so all of the kids played on Santa Monica Blvd.

My family then moved to 2823 Main St. It was an apartment building in 1934 but is currently a commercial building. In 1938, during the Depression, we used to go to Pico and Lincoln. There was a large lot there, and the government gave families free fruits and vegetables.

In 1942, we moved to 1523 Lincoln Blvd., where the Bay Cities Italian Deli and Bakery parking lot is currently located. I sold this property to Bay Cities when my mother passed away in 1972.

When we lived at 1523 Lincoln Blvd., I went to John Adams Junior High School, now John Adams Middle School. Will Rogers Elementary School had not yet been built. I also went to Santa Monica High School and Santa Monica City College. The college was on the northwest corner of Lincoln and Michigan at that time, and Michigan still went through to 4th St.

At that time, Santa Monica College was a trade school. If you wanted to be a carpenter, electrician, or plumber, this is where you went to school. At the corner of Lincoln and Colorado, where Denny's is now located, there was a gas station and tire recapping place, and I used to work there after school and on weekends. Across the street, where Norm's restaurant is currently located, was the city dump.

The Big Blue Bus did not exist at that time. There was, however, a small brown bus which used to go from Santa Monica south on Main Street, turn right on Pier Ave. and go west to the Boardwalk. It then drove onto a round turntable, turned around, loaded passengers, and returned to Santa Monica.

Just a few yards from the bus turntable were the Ocean Park Pier, the Dome Theater, and the Rosemary Theater. Also located in the same area was the Aragon Ballroom. We used to go dancing there on Friday and Saturday nights. All the big bands and singers performed at the Aragon, including Tommy Dorsey, Frank Sinatra, Bing Crosby, and Lawrence Welk. My friends and I also used to gather at Henns drive-in restaurant on 10th and Wilshire to have a soda and visit.

I enjoyed my life in Santa Monica very much.

City Staff to Speak at Annual Meeting about the "Monster Mansion" Ordinance Now Affecting Sunset Park

representative of the Santa Monica City Planning Division will be coming to speak to residents at the Friends of Sunset Park annual meeting on June 7th at 2 PM at Mt. Olive Church. The subject will be the impact of the interim ordinance that extended the so called "monster mansion" ordinance to Sunset Park. The speaker will address the general impact of the ordinance on remodeling and building new homes in Sunset Park and also discuss the reasons for its enactment. Another topic to be discussed will be the public process that

will take place in crafting an ordinance to create permanent standards.

This ordinance has a direct impact on the size of the home you can build and on what your neighbors can do as well. The speaker will take questions. However, if you are contemplating remodeling your current home or building a new one soon, you are encouraged to contact the City Planning Division at 458-8341 to get answers regarding your specific situation.

FOSP Can Help the Community **Evaluate New Development**

The City of Santa Monica has had a long-standing policy of advising commercial property owners (retail, office, apartment buildings) who are remodeling or doing new building to contact the neighborhood group(s) in their part of the community in order to get feedback from the community that can improve the development and t help understand the concerns of the community.

Owners have increasingly contacted FOSP, with the most notable example being the owner of a retail center at 2901 Ocean Park Blvd. who is proposing changes which include reconfiguring vehicular access. The owners accepted FOSP's invitation and presented their plans at a recent monthly meeting. The owner is also holding separate meetings with the immediate neighbors. The City encourages owners to involve the community in the process to make sure development is responsive to community concerns and so that owners do not have difficulty later in getting their project approved because of last minute community objections.

This is a voluntary program both for the owners and the community groups. Depending on participation from you, FOSP is considering sponsoring more such meetings. Generally, we plan on keeping such involvement limited to major development plans that we think will have a significant impact on the community. If you hear about new development and have questions, you can check the City's website for details or contact the City Planning Division at 458-8341. Council Approves Weight-Based Landing Fees for S.M. Airport BY CATHY LARSON

n Tuesday, May 13, 2003, the Santa Monica City Council voted to amend a City Ordinance establishing Weight-Based Landing Fees at the Santa Monica Airport. In 2000, Airport Staff engaged the services of Pavement Consultants, Inc. (PCI) to conduct an analysis of the Airport's runway and taxiway pavement infrastructure. The results of this analysis showed a direct correlation between aircraft weight and degradation of pavement surface.

Pavement maintenance is essential to the safety of airport operations. PCI estimated costs of pavement maintenance and repair at \$8,060,000 for a 15 year period.

The ordinance amendment will distribute the responsibility for pavement maintenance proportionally according to the aircraft's respective weight, from no fee for light aircraft (under 10,000 pounds) to \$348 for aircraft approaching 60,000 pounds.

Based on both economic and safety issues, the Friends of Sunset Park Airport Committee supports the City Council's approval of Weight-Based Landing Fees.

Aircraft Emissions

meeting with the Ad Hoc Committee of Airport Commissioners, Environmental Task Force Members, and Airport Staff with the Air Quality Management District (AQMD) has been in the planning stages for several months,

but no date has yet been agreed upon. The topic will be aircraft emissions and what can be done to mitigate their impact on the communities surrounding urban airports such as Santa Monica.

Pilots Association Sues City

The Santa Monica Airport Association (SMAA), a group of local pilots, has sued the City of Santa Monica. Included in this lawsuit is a challenge to the 95 decibel (db) noise limit. The lawsuit is projected to last until June. The 95 db level is set forth in the 1984 Agreement between the FAA and the City of Santa Monica as protection for the community. The City is aggressively fighting to uphold this protection.

Unfortunately, this trial has kept city staff from working more aggressively on the Aircraft Conformance Standards and Safety Zone Implementation.

Airport Staff have had ongoing meetings with representatives from the FAA in Washington regarding the implementation of the Aircraft Conformance Standard (B-II Standard) and Safety Zones. These proposed safety enhancements would create "size appropriate" standards for aircraft utilizing Santa Monica Airport. Currently 50% of the jet aircraft (basically the larger ones) using the airport are not compliant with the FAA's own Safety Guidelines for the runway length at Santa Monica Airport. Also, Santa Monica Airport currently has no safety zones at the ends of the runway. Establishment of safety zones, a 300-foot declared distance of unusable runway at both runway ends, compliant with FAA standards, is paramount to the safety of the surrounding residences.

City to Remove Ficus Trees

The Open Space Management Division plans to remove and replace 23 mature ficus trees on 32nd Street between Pico and Ocean Park Blvd. A public meeting to discuss this project will be held on Wednesday, June 4, at 7:00 PM in the Marine Park Auditorium, 1405 Marine Street. How the State Budget Crisis Affects SMC

om Donner, executive vice president of Santa Monica College, spoke at our April 2nd meeting. He gave us an update on how the State budget crisis will affect SMC: all classes at John Adams are canceled; September 2003 student fees probably will be \$24 per unit, up from \$11; some classes were cut and more reductions are likely. He also reported that the Library will open in the fall and will be available to the community. The Liberal Arts building will be replaced by new construction in the middle of the campus and the old building will be torn down, Donner reported. On traffic and parking, Donner said free shuttles will continue from the airport and parking on campus will be increased to \$75 from \$50. In the long term, SMC would like to change the shuttle route to run down Centinela and Bundy to Pico and then to a transit area on campus.

We appreciated Tom Donner's time and asked to be kept informed. Donner said he is willing to work with FOSP on issues such as transportation. As everything SMC does affects the neighborhood, we would like to work together.
