Santa Monica Airport News

urrently, the City of Santa Monica is fighting the FAA's challenge to an ordinance passed last March banning the faster, unsafe Class C and D aircraft at the SM Airport. The FAA succeeded in their request to enjoin the implementation of the ordinance until rulings have been issued.

The issue is being heard in two forums: (1) An administrative hearing through the FAA, called a "Part 16 Hearing," where a federal hearing examiner issues a ruling after the sides present their evidence and positions, and (2) the Ninth Circuit Court of Appeals.

An informational item is scheduled for the *Tuesday, November 11th*, City Council meeting regarding S.M. Airport Runway Safety Enhancements. The federal hearing examiner has ordered the City and the FAA to a "prehearing mediation." This informational item presents some possible options that this upcoming closed, confidential mediation hearing may discuss.

The agenda item is 3-A. "Report on status of dispute with the FAA and the alternative of enhancing airport runway safety through the use of EMAS technology, and request direction to staff relative to the required mediation with the FAA."

Hard Times for the Economy Means Extra Demand for the Westside Food Bank

hanksgiving is fast approaching. Westside Food Bank is in need of Frozen Turkeys for the Holidays! Please consider holding a frozen turkey drive or simply donating a frozen turkey for a local family in need this holiday season.

As more and more people are experiencing hardship because of the current economy, the Westside Food Bank (WSFB) has been experiencing extra demand for food. The number of people who must depend on help in order to eat has been rising steadily.

Are you moving? Do you know anyone who will be moving? Consider taking your nonperishable food items to the food bank rather than taking them with you or tossing them. The containers must be unopened. Health Department regulations prevent the food bank from accepting those halfeaten pizzas you had left over from the big party or packages of any open packages of food.

If you have food that you can spare, please consider giving it to WSFB. When you are grocery shopping (Costco, etc.), it would be a wonderful gesture to pick up some extra items to help those people who have been hit the hardest with rising prices for food and other basic necessities.

The Westside Food Bank does not distribute the food directly to individuals. The food is provided to 65 human services agencies which provide food to the elderly, the disabled, veterans, abuse victims, schoolchildren, and others who are food insecure. Most of WSFB's food reaches low-income individuals and families via food pantries that distribute grocery bags of food. WSFB's food reaches over 83,000 local people each year, nearly half of whom are children.

Recent figures have shown a marked increase in the number of people seeking assistance. In the past six months, WSFB's member food pantries reported that 19% more people sought food assistance as compared with the same six months in 2007. Even middle income families are finding it difficult to meet their basic needs without some food assistance.

Any nonperishable items are gladly accepted. Protein-rich foods, baby food and infant formula are in especially high demand, and supplies are running very low. Tuna, peanut butter, and other high protein foods are a cost item usually outside the normal WSFB budget. Children need protein for growth, emotional well-being, and for their IQ¢s. Adults need protein to guard against a wide variety of health problems.

New John Adams Middle School Athletic Fields Open

On November 1st, community youth soccer teams inaugurated the use of the new JAMS field, complete with the same artificial turf used by many NFL and college teams, new fencing and new lights. And on November 3rd, students at the middle school began using the outdoor complex.

The \$3 million project was funded by Measure S, the 2002 Santa Monica College bond measure, and was a result of cooperative planning between the college, the Santa Monica-Malibu Unified School District and the City of Santa Monica.

The athletic complex — which had been heavily used by the middle school, SMC and the community — consists of three fields: one for soccer, one for either soccer or football, and one for softball. It replaces a complex of grass fields, which had to be closed periodically for rain or for re-seeding. Because of their new FieldTurf surface, the fields' use can now be increased by as much as one-third.

The fields are used during school days by John Adams students for physical education classes and for unstructured recreation during recess and lunch breaks. After hours, they are used by the city's Youth Sports program and by community groups such as American Youth Soccer Organization and Pony League teams.

On Saturday, AYSO has scheduled 11 games beginning in the morning, and on Sunday the fields will be used for soccer scrimmages, practices and drills.

The John Adams fields had also been used by the SMC's women's soccer team for practice and games, but those have been moved to the college's Corsair Field because it, too, recently got a FieldTurf surface that works for both soccer and football. The John Adams field will now be used for practice and games by the SMC women's softball team, which had been playing in city parks.

And the Emmalie Award goes to...Emmalie!

he Emmalie Award is given each year to the FOSP member who has demonstrated unusual commitment, energy, and perseverance in serving the neighborhood. This year's Emmalie Award was given at the June 14th Annual Meeting to the person for whom it's named: Emmalie Hodgin.

Emmalie is a founding member of Friends of Sunset Park and has been on its Board since 1989. Emmalie grew up in Louisiana and met her husband Charles here in Santa Monica. They bought their Sunset Park home in 1957 and raised four children here. Charles worked at Douglas Aircraft Company and Emmalie was active in PTA and taught pre-school, among many other activities. For the last nineteen years, Emmalie has kept the FOSP Board on the straight-and-narrow with her sage advice and her determination to do what is right for our neighborhood and for the city. Her eloquent (and sometimes fiery!) speeches at City Council meetings are legendary.

A Very Condensed Version of the Staff Report for Agenda Item 3-A on November 11th

The current controversy reflects the Airport's unique characteristics, i.e., the airport is surrounded by homes and there are no runway safety areas to protect the adjacent neighborhoods from an overrun. There is little or no space available to create safety areas without using part of the runway, and doing so would affect access to the airport by some types of aircraft.

Fleet changes in the years since the 1984 Agreement created new safety risks. The City addressed safety concerns by studying the options and formulating the Conformance Program, which would have used displaced thresholds to achieve safety areas for A and B aircraft, and would have limited Airport usage to aircraft which conformed to the its design by banning C and D aircraft. In 2002, the FAA reacted to this proposed plan by initiating the current administrative proceeding to challenge the proposal.

Since the Conformance Program was approved, EMAS technology (Engineered Materials Arresting Systems – crushable concrete beds at the end of runways to trap planes, similar in function to sand traps for runaway trucks) has improved and now provides an alternative means of enhancing safety. The possibility of installing EMAS at Santa Monica Airport warrants consideration. However, the SMO runway is too short to accommodate C and D aircraft if standard 500-foot EMAS beds are installed at either end of the runway, at a cost of about \$8.5 million each. Shorter EMAS beds would not protect nearby residents.

Possible policy goals and parameters for exploring any settlement opportunities include enhancing public safety and neighborhood quality of life by:

- protecting against overruns through runway safety improvements, including EMAS technology;
- maintaining and, if possible, enhancing the efficacy of the blast wall;

- 3. keeping the runway ends as far as possible from homes;
- 4. preserving neighborhood aesthetics; and
- 5. ensuring that neighbors at both ends of the runway are benefited by any voluntary resolution.

Protecting the City's fiscal health and attendant ability to continue funding a wide variety of City services and programs by:

- 1. insulating the City against future liability claims by striving to meet federal runway safety standards;
- containing the cost of safety improvements and covering them, to the extent legally possible, through use fees; and
- 3. containing legal coasts by fully exploring any possibility for voluntary resolution.

Staff suggests that the Council consider the information provided in this report, *the public testimony*, and any other information provided at the public hearing, deliberate on the goals to be pursued in the mediation process, and give staff general guidance to establish parameters for the mediation process. We urge residents to attend. The council meeting will be broadcast on CityTV (Channel 16 on both Time Warner and Verizon).

Ninth Circuit Court of Appeals Hearing

In addition to the upcoming mediation, the Ninth Circuit Court of Appeals is scheduled to hear the City's challenge to the Interim Cease and Desist Order prohibiting the enforcement of the C and D ban on *November 19th*, at 9:00 AM, at 125 S. Grand Avenue in Pasadena. This court hearing is open to the public, and we urge residents to attend. The courthouse is located about 25 miles from downtown Santa Monica.

Community Oriented Policing Program

he Santa Monica Police Department's Community Oriented Policing program now includes the Neighborhood Resource Officer (NRO). The NRO is the direct link between the community and the Police Department. The NRO is best described as the "small town sheriff" for each patrol beat and will provide a personal contact to anyone living, working, or visiting within the specific beat patrol. If there is an emergency or routine police service request, the public should continue to use 9-1-1 or the non-emergency line (310-458-8491). However,

if there is a reocurring concern, or developing crime trend, or other non-routine need for service, the NRO will be able to assist. NRO's are available to attend community meetings and events; engage in regular patrols; and conduct proactive crime prevention. They can be contacted through e-mail, cellular phone, or a phone call to their office.
