## Santa Monica Airport Update

#### Airport Safety Measures Held Hostage

For years there have been concerns regarding the close proximity (less than 250 ft) of the Santa Monica Airport's runway ends to neighborhood homes. On March 25, 2008, the city of Santa Monica passed an ordinance banning unsafe, faster Class C and D aircraft from the Santa Monica Airport. The City based the new law on the FAA's own recommended safety standards.

Unfortunately, the FAA deemed access for the unsafe, faster aircraft more important than the safety of the residents. The agency filed for a "cease and desist" order and the U.S. District Court granted a temporary restraining order, which was upheld by the 9th Circuit Court of Appeals on May 8, 2009.

The FAA also challenged the City's new ordinance with an administrative review process called a Part 16 Complaint. A ruling is expected this month. There is a sense that no matter which side the Hearing Officer rules in favor of, the opposing side will appeal. Meanwhile, Airport neighbors continue to live under threat of an aircraft careening off the end of the runway.

#### **EPA to Conduct Lead Particulate Study at the SM Airport**

A presentation was made at the January 2009 Santa Monica Airport Commission meeting regarding a study of airborne lead particulates being conducted by the EPA. Currently, fuel for propeller planes still contains lead. The EPA's study of the dispersal of lead into the environment by aircraft exhaust, set to commence in June 2009, could lead to new standards for aircraft fuels.

## NEW Museum of Flying to Hold Community Outreach Meeting Saturday, May 16, 2009, 2 PM, 3100 Airport Ave. (adjacent to the new DC-3 monument)

The Santa Monica Airport staff is working with the Museum of Flying to ensure that the new location is compatible with adjacent businesses and neighborhoods. They have invited all interested parties to review the site improvements and operational plan. While the museum was formerly located on the north side of the Airport, the new site is considered more desirable because of its close proximity to the DC-3 monument. #### Airport Commission Looking at the Airport's Future

With the expiration of the operating agreement between the City of Santa Monica and the FAA approaching in 2015, the Santa Monica Airport Commission, at its April 2009 meeting, requested that a representative from the City Attorney's office make a presentation regarding documents that may have a determining factor on the use of Airport land after 2015. Airport Commission meetings are open to the public and are usually scheduled the fourth Monday of each month at 7:30 pm, in the City Council chambers. ## 20<sup>th</sup> and Pearl: Still "Grand Central Station"

Big Blue Bus Traffic on 16<sup>th</sup>, 17<sup>th</sup>, 20<sup>th</sup>, & Pearl Streets

t has been one year since the FOSP newsletter article "Twentieth and Pearl Turns into Grand Central Station" was published. It described how residential sections of 16<sup>th</sup>, 17<sup>th</sup>, 20<sup>th</sup>, and Pearl Streets had become inundated with Big Blue Bus (BBB) traffic, beginning in August 2007.

Most of the bus routes on these streets are serving Santa Monica College (SMC) at the neighborhood's expense. With buses idling within mere feet of homes, and with schedules running from early in the morning until late at night, sometimes at sevenminute intervals, the burden unfairly carried by the surrounding residential neighborhood remains.

Each weekday, the intersection of 20<sup>th</sup> & Pearl hosts over 20,000 car trips (north/south cut through traffic and SMC students), privately run SMC Intercampus Shuttles (White Deer), and four BBB routes. This intersection is uniquely situated between Grant Elementary, John Adams Middle School and SMC, and more than 130 elementary and middle school children use the crosswalks daily.

BBB has the following routes running through this area:

- ◆ Crosstown Ride/No. 11, Monday thru Friday, 6:59 AM thru 10:10 PM (every 15 minutes);
- ◆ Sunset Ride/SMC Intercampus Shuttle, Monday thru Friday, 7:00 AM thru 6:00 PM (every 15 minutes);
- ◆ SMC Commuter/Line 6, Monday thru Friday, 7:30 AM thru 6:55 PM (7 buses per day);
- → SMC Intercampus Shuttle/Bundy Campus Evening, Monday thru Thursday, 5:30 PM thru 10:10 PM (every 15 minutes).

The SMC Intercampus Shuttle (White Deer) serving the Performing Arts Center, which runs Monday thru Friday, 7:30 AM to 5:30 PM, has also been seen on 20<sup>th</sup> and Pearl Streets, although it's supposed to pick up and drop off at Parking Structure A on Pico Blvd.

This adds up to 129 buses passing a few feet from homes morning, noon and night!

A portion of these bus routes is being supported monetarily by the Associated Students and SMC through a partnership, and SMC students and staff

## Help Prevent Auto Burglaries

uto burglaries are mostly crimes of opportunity. With a little time and effort, you can reduce your probability of being a victim. The increase in auto burglaries is part of a national trend.

Do not keep your valuables in plain view in your vehicle. Take them with you, or place them in your trunk but before you arrive at a location where people might be watching.

Do not leave your vehicle registration in your car. It should be kept with your driver's license. Your GPS and other equipment, such as airbags and stereos can also be targets.

Always close your car windows and lock your doors, even if you plan to be gone briefly. An open door or window allows a thief a quick and quiet way to steal your property. Even when the window is only slightly open, it makes the thief's job easier. If your vehicle has an alarm system, be certain to activate it.

Thieves look for vehicles that they can enter with the least possibility of being seen or caught by citizens and authorities. Try to park in well-lit areas where your vehicle is visible to others. Be aware of your surroundings prior to leaving your vehicle.

Report suspicious people or vehicles in your neighborhood. Report suspicious persons wandering around looking into vehicles as they walk. Wait until your security gate or garage door closes before leaving your residential parking area.

Remember, if the crime is "in progress," call 9-1-1. To report an auto burglary that has already occurred, and if the suspect is gone, call the SMPD non-emergency number, (310) 458-8491.

ride for free. These routes are advertised on SMC's website as "college serving." This advertisement runs contrary to the BBB's assurances that the routes are "community serving."

The neighborhood was also assured that smaller, quieter buses would be used on these lines beginning in spring 2008 but, to date, there are still 40-foot full-size buses traveling through the area and negotiating turns that often require cars in the opposing lane of traffic to back up. To paint a better picture for you, the same huge 40-foot buses that you see on Ocean Park and Pico Boulevards are also traveling on 16<sup>th</sup>, 17<sup>th</sup>, 20<sup>th</sup> and Pearl Streets every day.

Residents have strongly urged BBB to re-route these buses out of the residential areas and onto main arterials, not only because of the noise and dirt pollution, but because of the dangerous conditions these buses pose to school-age pedestrians and to the families, children and pets that live on these narrow streets.

The FOSP Board of Directors has conveyed the neighborhood's legitimate concerns to BBB, as well as to the SMC Board of Trustees and the City Council. Due to the tenacity

and persistence of residential outcry, letter writing, e-mailing, and meeting attendance, some small changes have been made. But there is still a lot of work to be done so that residents in this area of Sunset Park get some relief and regain the quality of life they previously enjoyed. A middle ground can be found while still allowing the BBB to serve the college and its growing student population.

If you would like the college-serving bus routes (SMC Commuter/Line 6, Sunset Ride/SMC Intercampus Shuttle, and the SMC Intercampus Shuttle/Bundy Campus Evening) to be moved off of 16<sup>th</sup>, 17<sup>th</sup>, and 20<sup>th</sup> Streets and onto Pico and Ocean Park Boulevards, please e-mail your comments to Stephanie Negriff, BBB Director of Transit Services, at Stephanie.Negriff@smgov.net, Dan Dawson, BBB Customer Relations Manager, at Dan.Dawson@gov.net, City Manager Lamont Ewell@Manager at smgov.net, and Friends of Sunset Park at FriendsofSP@yahoo.com.

### **SMPD Receives Centurion Award**

n April 30, 2009 the Santa Monica Police Department's Neighborhood Resource Officer Program received the Peace Officer Association of Los Angeles County 2009 Centurion Achievement Award for Excellence in Community Policing. SMPD was selected for this award from all the law enforcement agencies in L.A. County.

The Neighborhood Resource Officer Program was developed in January 2008 in order to provide the community with a direct contact with the Police Department. It takes the "Andy Griffith small town sheriff" approach to policing, in which everyone in the community has personal contact with the Police Department. In 2008, the SMPD Neighborhood Resource Officers attended over 650 community meetings and personally met with more than 6,500 people to discuss safety concerns.

Also, remember that when you dial 9-1-1 from a cell phone, you may end up talking to a California Highway Patrol dispatcher, who would then connect you with SMPD. If possible, program your cell phone with the SMPD Non-Emergency Dispatch number, 310-458-8491, which will connect you with the same SMPD communications center as 9-1-1.
