Parks & Recreation Master Plan Update – August 25 Workshop

he first community workshop will be held on Saturday, August 25, from 9 AM to noon, at the Civic Center Auditorium, East Wing. Doors will open at 9 AM and the presentation will start promptly at 9:30 AM.

If you want to advocate for any of the following, this will be your opportunity to do so:

- ➤ development of a "Great Park" when Santa Monica Airport closes in 2029, i.e., what kind of park do you want to replace the airport?
- ➤ funding for the Airport Park Expansion Project – Latest design renderings are posted here: https://www.rchstudios. com/projects/santa-monica-airportpark/
- ➤ improvements at Clover Park, Marine Park and/or Ashland Park

At the workshop, staff will share what they heard from the community and present results from the online and pop-up surveys. The intent of this first workshop is to develop the community vision for the Parks and Recreation Master Plan Update. A light breakfast will be served. Free parking validation will be available for the Civic Auditorium Parking Lot, and bike valet will also be provided.

Santa Monica College

all semester classes begin on Monday, August 27. The college plans to demolish the YWCA building at 2019 14th Street and use the property for parking for SMC buses and vans. It will also demolish the Foster Freeze building at 1530 Pico in order to install a trailer for its construction management company and provide parking for their staff.

Santa Monica Airport (SMO)

n August 14, the City Council adopted Minimum Standards for Commercial Operations at SMO. The Minimum Standards will, as an addendum to the City's Leasing Policy, build on the existing commercial operations permit and leasing processes to (a) provide concise and reasonable threshold entry requirements for persons or entities wishing to provide commercial aeronautical services to the public at the Airport, (b) prevent irresponsible, unsafe or inadequate services, and (c) prevent unfair competition. The Minimum Standards will not apply to non-aviation tenants of the airport.

Legal Challenges Denied

In a judgment handed down on June 12, the U.S. Court of Appeals for the D.C. Circuit rejected a challenge to an historic Consent Decree that allowed Santa Monica to shorten the runway at Santa Monica Airport (reducing jet traffic by over 80%) and gave the City the absolute right to close the airport at the end of 2028. "The ruling by the D.C. Circuit affirms yet again that our agreement with the FAA is sound," said Mayor Ted Winterer. "One year in, we see the terms of the agreement in action are working. The runway shortening has significantly reduced jet traffic and we are steadily creating a plan to convert airport land into a great park that will benefit the entire community.'

On July 5, a Central District of California judge dismissed a challenge to the consent decree by Barry Rosen and denied further opportunity to amend the complaint.

Despite recent legal setbacks, the National Business Aviation Association (NBAA) and local airport advocates, including the Santa Monica Airport Association, Bill's Air Center, Kim Davidson Aviation, Redgate Partners, and Wonderful Citrus, are continuing their fight to prevent SMO from closing in 2029 by filing separate legal actions in the U.S. Court of Appeals and the D.C. District Court.

Electric Scooters

(CALIF. VEHICLE CODE)

- > You can only ride if you have a valid driver's license or instruction permit.
- > Wearing a helmet is required for all ages.
- You must ride by yourself, and not with any passengers.
- > You must ride on the road, never on the sidewalk.
- > You may not park on the sidewalk in the way of pedestrian traffic.
- > You must not ride at night unless the motorized scooter is equipped with proper lighting equipment, including a front light source which is visible from the front and sides, and reflectors.

Shared Mobility Selection Committee

Land Use: Multi-Unit Use in R1

t appears that a company called Bungalow Living seems to be leasing homes in Sunset Park, adding bedrooms, and then renting individual bedrooms out like college dorm rooms. This is considered "multi-unit use," which is not allowed in single family neighborhoods (R1 zones). If you are concerned about the use of a property, you can file a complaint with the city's Code Enforcement office so they can investigate what's occurring at the property. Complaints may be filed by:

Telephone Scams

Tech Support: If someone claiming to be from Microsoft, Apple, or another tech company calls to ask if you've had computer problems, just say no and hang up. No one is "watching" your computer for signs of a virus.

"Can You Hear Me?": Pause before speaking if a caller starts by asking, "Can you hear me?" By getting you to answer "yes" to that one question at the very beginning of the call, scammers can record your affirmative answer. They can use that recording to claim you agreed to pay for some scam program. Rephrase your answer to, "I hear you just fine."

IRS Impersonators: Don't freak out if someone claiming to be from the IRS calls to collect money. Scammers sometimes use fear tactics and threaten to send the police if you don't pay up immediately. The only way the IRS will get in touch with you is through the mail, on official letterhead.

Bank Calls: If your bank calls and asks you to confirm if transactions are legitimate, feel free to give a yes or no, but don't give any more information than that.

Grandparent Scam: Scammers sometimes target elderly people, pretending to be a grandchild. On a crackly line, they'll say they're in trouble—maybe they lost their wallet in a foreign country—and need you to send money. Unless you can confirm it's actually a relative, don't give any money.

Donation Collections: When charities, political parties, and lobbyists request donations over the phone, some will be legitimate, some will not be. Tell the caller, "Send me something in the mail. I want to read about it."

Jury Eligibility: Some scammers claim they're from the jury commission. If they ask for your Social Security number to confirm if you're eligible for jury duty, don't give away any information.
