Miramar Hotel Expansion Approved

ccording to ABC 7 News, "It's one of the most coveted pieces of land not just in Santa Monica, but all of L.A. County: The Fairmont Miramar Hotel at Ocean Avenue and Wilshire Boulevard overlooking Santa Monica Bay. A half-billion dollar re-development of the property, 10 years in the making, was approved by the Santa Monica City Council Tuesday night [September 29]."

The agreement will allow the developer to double the size of the Miramar. The new building will create a 130-foot tall "wall" along Second Street, blocking sunlight and ocean breezes, and it will include more than 60 luxury condos selling for \$7 to \$10 million dollars apiece.

According to Mary Marlow of the Transparency Project, the Miramar Hotel owners managed to use a loophole in 2006, when they purchased the Miramar property for \$200 million, to save an average of \$1.4 million every year in property taxes. That means the County of Los Angeles, the City of Santa Monica, and the local school district lost around \$20 million in revenue over the past 14 years.

Housing Element Update: 8,874 New Apartments?

Per very eight years, California cities are required to update the Housing Element of their General Plans. The Regional Housing Needs Assessment (RHNA) is mandated by State Housing Law and quantifies the need for housing within each jurisdiction during each 8-year cycle. The state assigns the Southern California Association of Governments (SCAG) to divvy up allocations to individual cities and counties in Southern California. https://scag.ca.gov/housing

In the previous cycle, Santa Monica was required to zone for approximately 1,600 new housing units. For 2021–2029, SCAG has assigned Santa Monica 8,874 new housing units, of which 70% are required to be affordable. This would be a 9% increase

in housing units in our city. Meanwhile, Long Beach was allocated 5%, and Malibu was allocated 0.5%. There is no way the city can afford to construct 6,000 new affordable apartments by 2029, and yet our City Council ignored the October 2020 deadline to appeal the SCAG allocation.

At the Santa Monica Planning Commission study session November 18, Commissioner Mario Fonda-Bonardi voiced serious doubts about the RHNA allocation for Santa Monica.

Meanwhile, Santa Monica Housing Commissioner Leonora Camner (appointed by the City Council), who is also Executive Director of Abundant Housing LA, wrote in the *Los Angeles Times* in October 2019 that Santa Monica, with its "massive job base and access to rail," should be allocated a target of 14,155 housing units. https://www.latimes.com/opinion/story/2019-10-25/housing-crisislos-angeles-scag-homeless-development

Before retiring, former Police Chief Cynthia Renaud participated in a recent FOSP meeting, giving a brief update and answering questions. Interim City Manager Lane Dilg subsequently asked former Santa Monica Police Chief Jacqueline Seabrooks to come out of retirement to serve as Interim Chief of Police beginning October 26, 2020. Seabrooks began her law enforcement career in Santa Monica in 1982, then served as Police Chief in Inglewood from 2007 to 2012 before returning to Santa Monica to serve as Chief from 2012 to 2017. Car Break-ins "Why You Might Want to Wrap Your Car Fob in Foil" – 7/6/18 – Detroit Free Press

"Given that the best way to store your car keys at night is by putting them in a coffee can, what's an ex-FBI agent's advice to protect cars from theft during the day? Wrap car fobs in aluminum foil. "Although it's not ideal, it is the most inexpensive way," said a cybersecurity expert who retired in 2017 from the FBI....Now, as CEO of GlobalSecurityIQ, she suggests clients go online and spend a few dollars to buy a Faraday bag to shield the fob signal from potential theft. Imagine a traditional sandwich bag made of foil instead of plastic...."

Catalytic Converter Theft The catalytic converter (also known as a cat) is an emissions control device located in your car's exhaust system. Harmful gases from the engine flow through the cat, where they are transformed into water vapor and carbon dioxide. The result is a reduction in pollutants from the car's tailpipe. Thieves are drawn to catalytic converters because these devices contain certain precious metals, including rhodium, palladium, and platinum, which make used converters valuable to metal recyclers. Thieves only need a battery-powered tool or a hack saw to separate the converter from the exhaust pipe. Toyota Priuses and SUVs are popular targets due to easier access.

To prevent theft:

- Park in a well-lit, highly visible area (near security cameras when possible).
- > Park your car in the garage whenever possible.
- ➤ Buy a device that locks your car's catalytic converter in a cage made of steel wire rope.
- ➤ Park high-riding vehicles (i.e., trucks and SUVs) near low-profile cars. Doing so will make it difficult to access the converter on the taller vehicle.
- ➤ Etch your vehicle's license plate number or VIN number into the converter. This will make it easier to trace the converter if it's stolen.

Airport Red Light Petition As Southern California Edison has installed taller light poles in alleys in the Sunset Park neighborhood, they are required to notify the FAA about new poles installed near the Santa Monica Airport. The new poles are actually shorter than some neighborhood trees. The FAA merely "recommends" rather than "requires" the red lights. But until the City tells SCE to stop, more and more residents will have extremely bright red lights shining into their bedroom windows all night long. 
