Analysis of SMO Flight Traffic

Introduction

On Friday April 22, 2011, concerned residents of neighborhoods surrounding Santa Monica Airport (SMO) conducted a test of airport flights in order to accurately assess the nature and makeup of the flights occurring. Unlike earlier tests, we did not do a detailed study of flight path compliance or noise levels on this occasion. This report is one in an on-going series of such reports conducted by residents to monitor airport operations. The previous report analyzed traffic on April 15, 2011.

By looking up the registrations for each tail number together with other data from various flight tracking web sites, we were able to determine the operators of each aircraft and thus to break the flights observed into three major categories for the purposes of analysis:

- 1. Flight Schools and Training Flights
- 2. Jet Aircraft
- 3. Other Prop Aircraft Traffic

A total of 58 flights were recorded during the period from 12:00 PM to 3:00 PM, an average of one flight every 3.1 minutes. On this occasion 60% of all traffic (35 flights) was flight school and training related. A single plane (N2092L) operated by Skyward Aviation accounted for 30% of all flights.

This report represents a snapshot of operations on a single day. The "Trends" section presents accumulated data from this and earlier observations to gain a more complete picture of 'normal' patterns. The accumulated usage percentage for all 2011 observations is Flight School 58%, Jet 9%, Other 33%.

Types of Use




Figure 1 - Flight Breakdown by Usage Type

For the purpose of this analysis, category 1 (Flight schools and training flights) included not only aircraft that could be directly tracked to flight school operators, but also flights that did more than one takeoff and landing within a one hour period. These flights are mostly flying round SMO's local loop in order to practice takeoffs and landings. Figure 1 below shows the breakdown of flights according to the three usage types defined above.


Sixty percent (60%) of the flights were flight school and training related, 31% were other prop traffic, and 9% were jet traffic. As in previous reports, we have ignored helicopter traffic. The bar chart shows the distribution of these flights between the three categories over the time period studied.

Flight School Details

As this and earlier reports have shown, approximately 1/2 to 3/4 of flight traffic and noise tends to be caused by flight school operations. These percentages warrant additional analysis to compare and contrast the 'sociability' of the various

flight schools operating out of SMO.

Note that one flight school aircraft alone accounted for 30% of all observed SMO traffic on this date:

N2092L - 17 flights (Skyward Aviation)

Trends

By combining the results from this and earlier studies, we can obtain a better picture of typical patterns of use over the week.




Figure 2 - Percentage of SMO Traffic by Type

The pie chart in Figure 2 above shows the accumulated percentage of all flights observed during 2011 regardless of day. It currently shows that on average 58% of all observed SMO flights are flight school related, 9% are jet traffic and the remainder is other prop traffic. This data represents a total of 248 observed flights during a combined observation time of 13 hours. The bar chart to the right shows the accumulated percentage breakdown by day of the week (for the days that we have data).




Figure 3 - Percentage of Flight School Traffic

The pie chart in Figure 3 above shows the accumulated percentage of all flight-school flights observed during 2011 regardless of day. It currently shows that Justice Aviation is the largest flight school by traffic operations (37%) followed by American Flyers (19%) and then Skyward Aviation (14%). Other local loop traffic (for which the flight school could not be positively determined) accounts for 19% of the flight & training activity. The bar chart to the right shows the accumulated percentage breakdown by day of the week (for the days that we have data).




Figure 4 - Flight Departure Rate

The graph in Figure 4 above shows the accumulated average SMO flight departure rate (in minutes) for the various days of the week (for which we have data).
